1. Introduction

The term 'province' has not always had its slightly sleepy connotation. In the Roman Empire since the time of Augustus, a province was a (militarily conquered) territorial administrative unit outside Rome, and formally there was no difference between the provinces. But of course, the provinces had different potentials, so that administration of the "right" province could pave the way to Rome and higher office, while remote provinces meant irreversible decline.¹

In the Middle Ages, province then became synonymous with an ecclesiastical province as the administrative district of an archbishop.² From here, the term found its way back to its meaning as an administrative state unit.³ Namely in the Prussian Stein-Hardenberg reforms of 1815/1818, which created three regional levels of administration between the state superior administration and the municipalities: the provinces (from which, after 1945, several of the *Länder* (states) of the former occupation zones and the present-day Federal Republic were to emerge), the *Regierungsbezirke* (governmental administrative districts) and the *Landkreise* (shire counties).

With the growing importance of cities in the context of industrialisation, a mental association was added to their administrative and political significance. The province was not the metropolis, and since it was in the metropolises that the dynamism and power of modernity unfolded and not in the provinces, the term often took on a negative connotation that, depending on one's view of rapid modernisation, ranged from a longing for rural idyll to contempt for the backwoods. Carl Amery describes the complex sociology of provinciality in his anthology *Die Proving. Kritik einer Lebensform* (The Province: A Critique of a Way of Life) with the hypothesis of a triopoly of *urbs – province – village*:

The provincial man is an intermediate form, a cultural-anthropological amphibian. He lacks both the self-confidence of the villager, which arises from his limitations, and that of the city dweller, which arises from his insolence. And strangely enough, what the restless, city-addicted people dislike about the provinces, what they mock or curse, is by no means the village life as they understand it. On the contrary: romanticising the village is a projection of city life.⁴

Our guiding question is whether the provinces exist in an imaginary space of mental alienation, i.e. in the minds of those who look down on provincials from the supposedly standard-setting metropolis, or whether it is an empirically verifiable description.

The juxtaposition of city and country, metropolis^{5/6} and province, is now being clearly questioned for various reasons, and the largely negative connotation of the term province no longer seems to apply. On the one hand, there is the popularity of Juli Zeh's novels, which very aptly describe the contrast between the Berlin bubble and the neglected, backward rural life, or the new enthusiasm for rural life, especially among young families who can no longer afford or no longer want to live in the big city, as a romanticised, positive vision of the province. In a variation on Goethe's term *Akyanoblepsie*, the inability to perceive blue, Matthias Theodor Vogt, based on the metaphor "blue", which for Novalis stands for inner-worldly transcendence, has coined the term *Kyanoblepsie*, the ability to perceive "blue", for this dimension of rural life that is only possible outside urban areas and, at the same time, as a task for cultural policy.⁹

The temporal view encompasses both the future and the past, whereby – and this is the crucial point in our context – the past is perceived as a future beyond the future. The spatial view encompasses both the blue distance of the mountains and the fatherland of Thuringia. By crossing the boundary between the two, Heinrich performs the initiation rite of passing over the "threshold" (Novalis). Ernst Bloch later writes in the final sentence of *The Principle of Hope*: "Hat [der Mensch] sich erfaßt (...), so entsteht in der Welt etwas, das allen in die Kindheit scheint und worin noch niemand war: Heimat.« (Bloch, Ernst: *Das Prinzip Hoffnung*. Frankfurt am Main 1973, vol. 3, p. 1628). Neville Plaice, Stephen Plaice und Paul Knight tramslate (in "The Principle of Hope", MIT Press/Blackwell, 1986) as: ""If [man] has grasped himself (...), there arises in the world something which seems to everyone to be childhood and in which no one has yet been: homeland." This translation is bad, (a) because it does not emphasize the metaphor of "hineinscheinen in etwas" (like a torch or candle shining into something; (b) because "Heimat" is not "home" but "homeland". With Novalis, it is *patria est outopos, ubi nemo umquam fuit* (The fatherland is that no man's land where no one has ever been). A sentence shaped by the experience of uprooting that was so constitutive of the 20th century. With Novalis, it is the other way around: The 20-year-old Heinrich leaves childhood and, through the upcoming ,long wanderings, 'constitutes for himself the fatherland as a homeland that will shine to him from childhood—and unlike in Bloch's conception, he has indeed been there.. *Patria est, ubi fueram et quo tendo* (My homeland is where I once was and where I am drawn to go).

Strictly speaking, with his gaze encompassing both the future and the past (as a future beyond the future), Novalis posits a curvature of space 114 years before the general theory of relativity; to be precise, he describes an Einstein-Rosen bridge (the Schwarzschild solution describes the conditions in the vicinity of a black hole and shows that inside the black hole there is a connection to another space-time region). And this curvature of individual space is perhaps the core of what we call culture, namely the connection between the where from? with the where to? and the how? Where from: we are past-oriented in that we are subject to a historical process, both ontogenetically and phylogenetically. Where to: we are future-oriented in

On the other hand, the growing election results of protest parties or anti-system parties such as *Alternative für Deutschland* or, most recently, the *Sarah Wagenknecht alliance*, especially in rural areas of eastern Germany, are symbolic of the diverse, unresolved problems of the rural province: inadequate transport links, poor health, education and cultural provision, and an overall feeling of having been forgotten by the urban elites, who are supposedly only concerned with gender-neutral language or the legalisation of cannabis. ¹⁰However, the attributions made to the provinces or rural areas can also be even more negative. Political scientist Lukas Haffert writes in a book published in 2022:

The revenge of the villages. The rural revolt. The uprising of places that don't count. The rebellion of the disenfranchised and left behind, the losers of globalisation who feel like strangers in their own country. These are some of the phrases used to describe the common core of various political shocks in recent years, from the election of Donald Trump to Brexit to the yellow vest protests in France. The attack on liberal democracy seems to be concentrated in rural areas, in places far from the big cities, where small factories, mining or forestry once provided modest prosperity and secure jobs and which, following the decline of these industries, are now sinking into post-industrial resentment.¹¹

In a book on democratic regression published in 2021, Armin Schäfer and Michael Zürn write about the causes of authoritarian populism and blame it on new lines of conflict that no longer run along the left-right axis but can be linked to the concepts of cosmopolitanism and communitarianism. While cosmopolitanism, in the authors' view, is individualistic, universalistic and generalisable, communitarianism emphasises the role of community and identity. Here, too, we can sense a negative description of rural areas and the provinces.¹²

Rural areas and the provinces are not doing well, not only because of structural disadvantages, but also because rural regions are perceived as backward and authoritarian, without always considering the causes on the one hand and focusing on the potential of rural areas and the provinces for reinventing society and community on the other.¹³ The perception of the provinces very often depends on one's own life plan and perspective, and not only on an administrative-geographical definition.

But what is the province today and what tradition does it represent: a backward-looking place where tradition lives on, a refuge from late modernity and a place where we can retreat to our childhood, or a place of modern renewal where we can escape the massification of the big city and explore new paths through late modernity?¹⁴

In the following, I will first explore the concept of province, its historical and current meanings (II), before going on to describe the characteristics of the current rural area in Saxony and the state's policy approach to rural areas (III). Building on this, I will conclude by attempting to outline the conditions for the province as a laboratory of late modernity (IV).

Within the framework of this metaphor, cultural policy would be the facilitation of strategies to overcome *akyanoblepsia*, or, to put it positively: to understand the historicity and spatiality of one's own situation, to answer the guiding question of the good life individually, and to constantly readjust one's actions within the process thus defined. However, this is not a demand on cultural policy in the usual sense, i.e. of theatre policy, museum policy, etc. Rather, it is a demand or even an assessment criterion for good politics in general. One could perhaps speak of culturally grounded politics."

2. What is the province?

In addition to the historical connotations of province as an administrative or ecclesiastical-administrative term, province is above all the counterpart to the metropolis, which, in addition to its geographical meaning, also refers to a mental state. Following on from the latter, the province is thus the opposite of hectic late modernity, which also means that the term province does not have a solely negative connotation. Yes, the province is certainly more backward, and the big debates or glittering career prospects are less common in the province.

However, whether this also applies to the latest trends in cultural life is highly questionable. As early as 1953 and again in 1967, Torsten Hägerstand explored the question of innovation cycles, whose origins he found primarily in extra-metropolitan areas. Peter Haggmann coined the term Beatles' pattern to describe this phenomenon: A musical style beginning in a provincial city (Liverpool) moves to the national capital (London), and then on to other capitals throughout the world. The same applies to Japan. This effect can be studied in detail in theatre history: important inventions regularly originated in the provinces and found their way from there to Vienna, Berlin or Munich. Compare this with the self-referentiality along the lines of inner-metropolitan debates in the study by Matthias Theodor Vogt and his students in a moot court at the Görlitz Regional Court, in which the funding decisions of the Cultural Foundation of the Free State of Saxony were critically analysed along the dichotomy of large cities vs. rural districts. The dignity of Saxons depends on where they live, as Matthias Theodor Vogt succinctly stated in the Sächsische Zeitung.

The province is therefore by no means just a place that has been left behind, as it may be perceived by some urban observers. In 2022, the magazine project 'Berliner Debatte' devoted an entire issue to the province, with the editors pointing, among other things, to the accompanying phenomena of the province, where the consequences of the pandemic seemed to be easier to cope with.¹⁹ At the same time, however, the provinces continue to be associated with a variety of negative characteristics: poorer life chances, weaker infrastructure and, last but not least, political backwardness, which is reflected in electoral successes and support for various populist parties and movements that are only found in isolated, deprived neighbourhoods in urban agglomerations.

However, this development is not set in stone and may only be a snapshot of the current situation. In the 2021 federal election, for example, there were significant differences between the results achieved by the Greens, with their traditionally urban electorate, and the Union and Alternative for Germany (AfD), which performed particularly well in rural areas, but this was not the case for the SPD and the FDP in 2021. No trends could be identified in terms of their electoral success in combination with rurality or urbanity.²⁰ Rural areas are therefore not automatically synonymous with populist voting

behaviour. The 2025 federal election, on the other hand, should not be taken into account here, as the result was more likely a punishment for the traffic light coalition government. Whether stronger and more lasting trends can be derived from this is uncertain.

It is much more likely that the aftermath of the double transformation shock will continue to have an impact on eastern Germany – even 35 years after German reunification, as multiple crises and the feeling of being second-class citizens in a united Germany are creating a dangerous mix in eastern Germany. A 2020 study by the SPD-affiliated Friedrich Ebert Foundation distinguishes between shock regions and winner regions in its explanatory approach.²¹ In any case, the successes of populist parties such as the AfD or Sahra Wagenknecht's alliance are significantly greater in eastern Germany than in the west, as was recently demonstrated once again in the state elections in Brandenburg, Thuringia and Saxony in 2024 and in the federal elections in February 2025.²² However, it is more than questionable whether the aftermath of a double transformation shock and East-West German discord are solely responsible for this voting behaviour. It seems to me that another significant factor is the disregard and contempt for rural areas, which also plays a major role. This development has been foreseeable for years, but in times of neoliberal economic policy, tight public budgets and the conviction that urban metropolises would also have a positive impact on the provinces, it is precisely these provinces that have been forgotten. The provinces are not so much the affluent suburbs surrounding the conurbations as the rural areas or the periphery.

On the one hand, the close connection between the province and the metropolis must be emphasised. Hans Ulrich Gumbrecht refers to the province as 'places of thought and passion', as he subtitles his essay from 2021. The province interacts with the metropolis like two communicating tubes. The metropolis needs the province as a counterpoint, but it hardly perceives its ambivalence:

In contrast to the metropolis, however, which experiences its periphery as an undifferentiated, homogeneous province, the province usually lies in the middle between a metropolis and those drastic villages that keep their confines closed.²⁵

On the other hand, this also gives the province an important social and political function as a mediator between the metropolis and the village and as a corrective and echo chamber for the metropolis.

In addition to the term 'province,' which has grown historically and evokes both negative and positive associations today, terms such as "periphery"²⁴ and 'rural area' are also used. Periphery already suggests marginality – both spatially and mentally-culturally, whereby processes of peripheralisation almost suggest a deliberate dwarfing towards insignificance in debates. In any case, the periphery refers to geographically and discursively marginalised spaces, and it seems unlikely that a positive connotation for the term can be found. Unlike the province, which in a positive sense can also represent a place of retreat – and possibly more than that – from the impositions of late modernity and urbanity, the periphery is synonymous with marginality, and periphery thus describes spatial inequalities that are also reflected in a lack of opportunities for political participation.²⁵ Other common characteristics of peripheral spaces are migration, dependence on the centre, loss of significance and a marginalisation in

people's minds, whereby marginalisation is a mixture of external and self-attribution.²⁶ In view of this negative syndrome, it is permissible to ask whether the term should be used at all beyond a social science description, as it makes attributions that may be highly exaggerated and criminally ignore the potential of these spaces.

In contrast, rural space is a geographical term that encompasses the functionality of rural areas, their political and economic constitution, their social construction and practices of rurality, and does not automatically evoke negative connotations per se.²⁷ At the latest since the spatial turn towards the end of the 1980s, which reassigned space a new meaning in sociology, geography, history and cultural studies, a meaning it seemed to have lost in late modernity with the acceleration of transformation processes and the apparent disappearance of distances, rural areas have once again become a topic of discussion.²⁸ They are no longer just the hinterland of metropolitan areas or forgotten, peripheral spaces, but places where society is also constituted.

The loss of significance of (rural) space associated with globalisation is now rightly being questioned again. Markus Schroer emphasises that spaces today are more diverse and overlapping, and that it is not only physical space but especially social space that constitutes our society.²⁹

Geography, with its natural connection to space, has provided a variety of starting points in recent years for, on the one hand, not reducing rural areas to their economic function and, where applicable, their dependence on economically favourable areas and, on the other hand, rejecting concepts and trends such as periphery and periphery research. The transformation of society towards more sustainable development, greater participation and public services, while at the same time demographic change is taking place, especially in rural areas, cannot succeed without the inclusion of rural areas and the maintenance of these areas in their economic and social function. However, this requires not only the acceptance of rural areas as social spaces and the associated safeguarding of social functionality (village life, regional identity, stabilisation of population development), but also a change in the narrative about rural areas. The conceptualisation of rural areas as backward and narrow-minded provinces is diametrically opposed to the participation of the rural population in the inevitable transformation of rural areas.

An important framework condition for dealing with rural areas is the constitutional requirement in Article 72, paragraph 2 of the Basic Law, which refers to the 'establishment of equivalent living conditions throughout the federal territory'. However, this also falls within the scope of concurrent legislation, which means that the federal states of the Federal Republic of Germany are also called upon to act in this direction. However, rural areas in particular have been severely affected by selective migration in recent decades, with young, well-educated people in particular moving to urban areas. The second demographic transition, which describes processes of increased life expectancy, declining birth rates and a diversification of household structures towards single-person households, is therefore having an even greater impact on rural areas. Under these circumstances, it is very challenging to guarantee local services in areas such as education, health and shopping. Geographical research is therefore now also investigating processes

that encourage people to stay, which depend on their own life plans on the one hand, but also, of course, on local structures on the other. In view of demographic change, staying in a region is often a conscious process that needs to be researched and supported by politicians through good framework conditions.³³

It is clear from the above that the strict contrast between metropolis and province should gradually become a thing of the past. However, this presupposes that the province, or perhaps better said, rural areas, are taken into account in the policy proposals of parliamentary parties and that the idealised claim to equal living conditions, which is enshrined in the Basic Law, is finally addressed. There is a need for integration between metropolitan areas and rural areas; intersections and transition zones could provide a feedback loop and regular exchange. Rural areas are not museums for postmodern city dwellers, but social spaces where society can be observed on a small scale and where new approaches to public services and cultural work can be explored.³⁴

It is essential to differentiate between different types of rural areas and to emphasise the microcentral function of medium-sized towns.³⁵ For example, their retail space per capita regularly exceeds that of metropolitan areas, as they are responsible for supplying the surrounding areas.³⁶ For this reason, the more objective term 'county area' has been proposed as a replacement for 'rural area'.³⁷

3. Provinces and rural areas in Saxony

Rural areas in Germany and Saxony have undergone massive changes in the 35 years since German reunification. In the 1960s, researchers tended to refer to rural areas in the singular, whereas today

In this intellectual-historical situation, even if it may sound paradoxical, the provincial periphery between several cultures takes on great significance for the defence against widespread tendencies towards provincialisation and the restoration of lost commonalities. An institution such as the Collegium Pontes, in a city whose "peripheral" location in relation to a cultural area also makes it the centre of a common European cultural area between countries and regions, gives rise to justified hope for a supra-provincial reflection on what once constituted Europe's common identity.

there is talk of a variety of very different areas, which also requires differentiation in the strategies and instruments for these rural areas. Some rural areas benefit from their proximity to metropolitan regions, while others are losing population significantly due to their greater distance from metropolitan regions. Structural change in Germany as a whole – and in eastern Germany with a delay and greater intensity from 1990 onwards – has reduced the importance of agriculture and forestry as sources of employment and thus the importance of these sectors for rural areas. Other areas of employment in the service, communications and leisure sectors have emerged to replace them.³⁸

According to the 2011 Federal Spatial Planning Report, rural areas³⁹ are differentiated according to their location (central vs. peripheral, with corresponding subdivisions) and their settlement structure (large cities, urban districts, rural districts with signs of densification, sparsely populated rural districts). This is intended to support strategies for strengthening rural areas.⁴⁰

The so-called Thünen typology, developed at the Thünen Institute for Rural Studies in Braunschweig, takes a different approach. Here, a distinction and typology of rural areas is proposed based on a total of five characteristics: settlement density, proportion of agricultural and forestry land, proportion of single-family and two-family houses, population in the vicinity of populated areas and distance from large centres. The index formed from this measures the degree of rurality at regional level in 361 district regions in Germany, 267 of which are classified as rural. Four types of rurality are represented: very rural/less favourable socio-economic situation; rather rural/less favourable socio-economic situation; very rural/favourable socio-economic situation and rather rural/favourable socio-economic situation.⁴¹

Rural areas can be found throughout Germany, with the two types of rurality with a less favourable socio-economic situation dominating in eastern Germany.

Given the continuing regional disparities, with structurally weak areas more prevalent in eastern Germany, it is therefore not surprising that an analysis from 2020 describes the development for Saxony as quite dramatic. Rural areas here refer to the entire area of Saxony outside the three major cities of Dresden, Leipzig and Chemnitz, although this somewhat imprecise definition can certainly be viewed critically in light of the typologies mentioned above. When it comes to structural change in rural areas, the authors note that although the population decline has been halted thanks to a rise in the birth rate, the cuts in the population have naturally also led to cuts in infrastructure. Schools and doctors' surgeries have been closed, public transport has been reduced, and many smaller shops and restaurants have shut down. The proportion of people employed in agriculture also fell to 1.3% or 27,600 employees in the Free State of Saxony in 2018, which is also changing the character of the villages.⁴²

A text by Matthias Donath printed in the same issue comes to a somewhat more positive conclusion with regard to the handling of cultural assets. Initially, the further deterioration of historic buildings was partially halted after reunification. Church buildings in particular were almost completely renovated, while the Free State of Saxony took over only 20 of the numerous castles and manor houses, about two percent of the total stock and thus significantly less than in other states of the Federal Republic, as Donath emphasises. ⁴³ Donath's conclusion is therefore mixed:

"When it comes to cultural use and cultural infrastructure, the picture is contradictory. The number of museums has increased, music schools are being used more, but there are fewer choirs, libraries and cinemas. The orchestra and theatre landscape has largely been preserved.

This was achieved by investing significant public funds in these institutions. At the same time, however, these are institutions with a very high need for subsidies. It is legitimate to ask whether this prioritisation, which is evident in the distribution of funds for cultural areas, is fair to other areas of cultural activity."⁴⁴

A Forsa survey commissioned by the State Office for the Environment, Agriculture and Geology in 2014 on rural living conditions in Saxony shows, somewhat surprisingly in view of these assessments, a high level of life satisfaction among the rural population, among other things with regard to nature and the different type of social contacts compared to urban areas. However, subjective deficits such as distance to work, poorer infrastructure and lower earning potential are also mentioned, but these do not detract from the overall positive conclusion.⁴⁵

However, the situation has changed dramatically in the meantime due to multiple crises (migration crisis, Covid pandemic, war in Ukraine) and the electoral successes of the AfD in particular, so that this positive assessment is no longer valid. The Deutschland Monitor, funded by the federal government and carried out by the universities of Mannheim, Jena and Halle-Wittenberg, noted fears about the future and uncertainty in its latest survey in 2024, particularly in structurally weak areas. Regional differences can jeopardise social cohesion. In this survey, 83% of respondents supported funding for structurally weak regions.⁴⁶

The Saxony state government has responded to the structural change in rural areas outlined above with a variety of strategies in recent years. The current strategy, Living Diversity – Securing the Future', which followed the 'Rural Areas – Living Diversity' strategy in force since 2012, aims to continue proven programmes but also to set new priorities, for example with regard to the employment of new teachers and police officers (financed by the Future Pact). In 142 pages and ten chapters, individual areas of life of Saxony's citizens are addressed and investments are promised in quality of life and livelihoods, in digital infrastructure for digital work, in local education, in health care, in science and research, and in culture. At the same time, the strategy promotes families and civic engagement, social cohesion and equal opportunities in rural areas, and promises adequate funding for towns and municipalities. Through so-called LEADER areas, local stakeholders will decide for themselves how to spend their money on the basis of local development strategies.⁴⁷

Culture is also an important element in maintaining rural communities and is therefore given special support by the Free State of Saxony under the 1994 Cultural Space Act. Rural traditions are to be preserved and culture is to remain visible throughout the region. On the basis of the Saxon Cultural Area Act, 95 million euros are earmarked annually for rural cultural areas, whereby, in accordance with the principle of subsidiarity, local authorities are also expected to contribute to the development of cultural areas. In addition, funds are available to improve mobility in rural areas and for municipal theatres and orchestras. Overall, the aim is to improve access to cultural offerings. The double budget just passed at the end of June 2025 is also more positive for cultural funding than feared. The planned cuts are less drastic, and some areas, like orchestras and Saxon cultural funding, are even getting more money. In other areas, like the Saxon Industrial Museum in Chemnitz, the cuts are pretty big, though. [50] In addition to the state strategy for rural areas, the regional budgets implemented with the LEADER areas are an important instrument for

promoting smaller projects in particular. In 2021, 29 local action groups in Saxony implemented 586 small projects with a total funding volume of 4.5 million euros. As a rule, this involves funding of up to 80%, with the average funding per project amounting to €7,660.⁵⁰

In addition to Saxony's state funds for cultural promotion, federal funds are also available, as the federal government has also recognised the need to promote rural areas. With the programme 'Aller.Land − shaping the future together. Strukturen stärken' (Aller.Land − shaping the future together. Strengthening structures), the federal government aims to "strengthen culture, participation and democracy in rural areas in the long term",⁵¹ as the integrative power of culture in an uncertain and increasingly heterogeneous society is now recognised. The federal government is providing a total of €69.4 million for this programme from 2023 to 2030, with €5.9 million being added by the respective regions as co-financing. Ninety-seven regions participated in the first phase in 2024, each receiving €40,000 to develop concepts. In the first half of the year, 30 of these regions were selected and can now implement their regional concepts by 2030. In a previous project, the Federal Ministry of Culture and Media (BKM) has already provided up to €20,000 in funding to cinemas, libraries, local history museums, cultural centres and cultural projects in communities from 2019 to 2025.⁵²

It is therefore clear that both the federal government and the Saxony state government have recognised the need to promote culture in rural areas for many years, not least in order to make local democracy more resilient. An exciting range of cultural activities close to home is one way of supporting and developing community and social capital.

In addition, rural areas could also be a testing ground for social debates and social cohesion. In urban areas, social cohesion takes place primarily through public discourse and opportunities that enable people to shape their own lives. However, given its more limited offerings, rural areas have other strengths, namely fewer barriers to social contact and smaller communities.

4. The province as a laboratory of late modernity? Proposals.

Perhaps, in addition to its administrative characteristics, the province is also a mental disposition. The province exists in the mind, and processes of exclusion are not only evident towards newcomers to rural areas, but also towards outsiders in urban discourse. What is more, perhaps the province is less closed in its discourse and in its constant state of emergence. In the province, there is no centre of debate, no geographical centrality, but rather a polycentric space with flat hierarchies, much more direct, even brutal, but also more open to new structures because, in addition to outdated and obsolete traditions of the old. This also makes the provinces a laboratory for modernity, where demographic, political and economic processes, i.e. the ageing of society, the redefinition of society in the 21st century with a new politics of citizen participation, and the negotiation of economic structures and infrastructures for the economy of the 21st century, can be observed and tested. There are no structures here to defend the old, no persistent forces that have become institutionalised in urban areas and make a new beginning so difficult because it is also associated with the loss of symbolic and institutional power. In the provinces, society can - or rather, could - be re-established. This requires a better infrastructure for encounters, and what could be better than culture? Transport routes and smart mobility solutions can be created relatively easily, albeit not cheaply, but without cultural meeting places, even better transport routes will not lead to the reconstitution of rural areas in the 21st century. However, this is precisely what is needed to re-establish an increasingly heterogeneous society.

Goethe points to the connection between prosperity and culture. In his 'Conversations with Goethe in the Last Years of His Life,' Johann Peter Eckermann notes on Thursday, 23 October 1828:⁵³

But if one thinks that the unity of Germany consists in the fact that the very large empire has a single large residence, and that this large residence is beneficial both for the development of individual great talents and for the welfare of the great mass of the people, then one is mistaken.

A state has been compared to a living body with many limbs, and so the residence of a state could be compared to the heart, from which life and well-being flow to the individual limbs near and far. But if the limbs are very far from the heart, the flow of life will be felt weakly and increasingly weakly. A witty Frenchman, I believe it was Dupin, drew a map of the cultural state of France and illustrated the greater or lesser enlightenment of the various departments with lighter or darker colours. There we find, especially in the southern provinces far from the capital, individual departments that are coloured completely black, as a sign of the great darkness that prevails there. But would that be the case if beautiful France had ten centres instead of one large centre from which light and life emanated?

What makes Germany great if not an admirable popular culture that has permeated all parts of the empire equally? [...] Suppose we had only the two capital cities of Vienna and Berlin in Germany for centuries, or even just one, then I would like to see what would become of German culture, and indeed of the widespread prosperity that goes hand in hand with culture!

Germany has over twenty universities spread throughout the empire and over a hundred public libraries equally widespread, as well as a large number of art collections and collections of objects from all realms of nature; for every prince has taken care to attract such beautiful and good things to his vicinity. There is an abundance of grammar schools and schools for technology and industry; indeed, there is hardly a German village that does not have its own school. But what is the situation in France with regard to this last point?

And then there are the many German theatres, numbering over seventy, which are by no means to be despised as vehicles and promoters of higher education. The appreciation of music and singing and their practice is more widespread in Germany than in any other country, and that is also something!

Decisive countermeasures must be taken to prevent rural areas from falling further behind. The strategy of the Saxony state government, 'Living diversity – securing the future', and the BKM initiative 'Aller. Land – shaping the future together. Strengthening structures' are starting points here. A few things seem central to this:

Firstly, it is important to continue supporting cultural spaces and to link cultural education and democracy education more closely than before. The BKM project has recognised this. A German-French-Polish position paper by the Genshagen Foundation calls for precisely this – the strengthening of culture in rural areas, as this is relevant to democracy and the system. According to the Genshagen paper, this support should be participatory in nature.⁵⁴

Secondly, political, economic and cultural elites must also engage in discourse in the provinces, take up the populist challenge and defend democracy. Here, too, local democracy projects should be strengthened, as is already happening in some cases – local democracy projects should be strengthened.

Thirdly, the periphery of rural areas must be consistently broken down through transregional and transnational cooperation. This can be done within the framework of Euroregions, through bilateral partnerships, in research projects and citizens' initiatives, again with a constant focus on strengthening democratic resilience. Much is already underway in this area, but these developments must be strengthened, as the problems faced by our neighbours are similar and all sides stand to gain from cooperation.

Fourthly, meeting places in small communities must be supported or established. Without such places, local communities cannot survive. It is important to strengthen voluntary work, as this organises and ultimately sustains local meeting places.⁵⁵

Fifthly, migration in rural areas should be made possible and strengthened in a sustainable manner, as this could cushion the impact of depopulation. However, this must be accompanied by measures to ensure that the advantages of rural areas, namely taking strangers by the hand and integrating them into the microcosm of the village, can also come to bear and reservations are broken down.⁵⁶

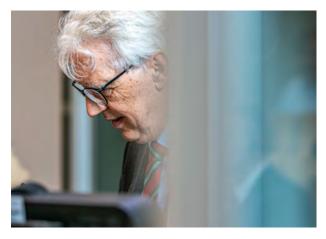

The Art Night took place at the 'Benigna' on Görlitz's Untermarkt, one of the city's most historically significant buildings. It is named after Benigna Horschel. On Pentecost Sunday 1464, she was impregnated by the mayor's son Georg Emmerich and then callously abandoned. The conflict between the Emmerich and Horschel families was to become a turning point in the city's history, far more exciting than the teenage drama Romeo and Juliet [https://kultur.org/wordpress/wp-content/uploads/Hoch Benigna Spannender-als-Romeo-und-Julia in Vogt-et-al-Benigna-2024-04-25.pdf].







In the fine tradition of debate among Görlitz students of 'Culture and Management' [https://kultur.org/wordpress/wp-content/uploads/Vogt_3Gruende-fuer-Goerlitz-als-Studiengangsort_Benigna-2024-04-25.pdf] with complex issues in the city and region (and often far beyond), the institute received an enquiry from Robert Lehleiter and Christian Weise. They wanted a concept for the use of the 'Benigna'. Supervised by Matthias Theodor Vogt and Maik Hosang, 12 female students and 1 male student explored this issue in a research seminar, in collaboration with council archivist Siegfried Hoche and a Bonn theatre group, supervised by René Harder.

Without immigration, Görlitz is lost,' said the then mayor Siegfried Deinege during research for the study 'Arriving in the German world' [https://kultur.org/forschungen/merr/]. However, immigration is a process in which preconceived assumptions – positive or negative stereotypes – play a decisive role in choosing a destination.

When Cameroonian mayor Roger Tafam promoted Görlitz in June 2023, he found that the city was so heavily disparaged as xenophobic on English-language social media that the parents of the young people he wanted to send to Görlitz for training vetoed the idea and none of them wanted to come.

The objective data tells a completely different story. No city in Saxony has a higher proportion of foreigners than Görlitz, not even Leipzig, and certainly not the state capital Dresden. Data from the Office for the Protection of the Constitution and the criminal investigation departments indicate peaceful coexistence (see Vogt 2023). If Görlitz entrepreneurs want to attract excellent workers in times of skilled labour shortages, they urgently need to counter the media's denigration with facts. The inglorious first-place finish of the Görlitz district in the European elections on 9 June 2024 has opened the door to further suspicions.

Roger Tafam suggested presenting parents with a film about the real Görlitz in English in YouTube format in order to respond to the allegations of 'manifest xenophobia' circulating on the internet. With the film 'Görlitz Rhythms – A Dance of Cultures' and in cooperation with the Municipal Hospital, the Maltese Hospital, the Zittau/Görlitz University and many civil society actors, the Institute implemented this idea together with Andi Zgraja, Görlitz (camera and editing).

The film is short and asks only one question: **What is so special about Görlitz?** The data is impressive and stimulates discussion.

To mark the institute's anniversary, we are making the film available to all Görlitz-based companies in two audio tracks: (a) with Leoš Janáček's 2nd String Quartet 'Intimate Letters' and (b) a brass recording. Which music do you prefer? And which one do you think your contacts will like best?

To listen, to reflect, to act Cultural Policy against the Grain

What are the premises of today's cultural policy? What insights can the past, present and theory offer for a contemporary cultural policy? How can art counteract agoraphobia, digital isolation and populist temptations? How can local authorities give their citizens ample space to develop civil society solidarity 'for the good of the city. For only when the city is well will you be well.' (It should be noted that Jeremiah 29:7 addresses immigrants who are to become citizens in foreign Babylon. Does our cultural policy also achieve this?) Are the arts not precisely the place where we can first listen to the other before we think together and then act together?

It is the historical achievement of Matthias Theodor Vogt, in the Free State of Saxony, which was re-established in 1990, to not only conceive the Saxon Cultural Area Act between 1991 and 1995 in a unique process of analysis and dialogue with the state, municipal and civil society levels, but also to have it enshrined in law and, last but not least, to have it implemented with little friction. It was therefore only natural that, on the thirtieth anniversary of the law's entry into force, the cultural areas of Saxony invited Matthias Theodor Vogt's colleagues and students to a conference entitled 'Kulturpolitik gegen den Strich' (Cultural Policy Against the Grain). We are hereby presenting the results of this conference in a commemorative publication to mark his 65th birthday.

What can art do better and differently than the digital world? What political, structural, economic, and, last but not least, intellectual conditions are necessary for art to develop its own life for the benefit of humanity? The cover image shows Haus Klingewalde, Görlitz, home of the Institute for Cultural Infrastructure Saxony since 1998. The watercolour by Lynne Beal, Cologne, relates to a conversation with Matthias Theodor Vogt about the vanishing point in Alberti: *De pictura* | *De pittura* (1435 – 1436). According to Corinna Laude, in the *centricus punctus* of Alberti's intromission theory, 'the orthogonal vanishing lines, the depth lines of the representation, converge "quasi persino in infinito" (as it were out into infinity), it lies in infinity – and thus, according to contemporary understanding, in God'. Which "vanishing points" does today's post-secular society use?

How can political science in Chemnitz interact in a multidisciplinary, cross-continental manner, always with reference to human beings themselves, with cultural studies in Tokyo and linguistics in Leipzig, with legal studies in Naples and social sciences in Rome? This volume shows that cultural policy studies require a fact-based holistic approach and that this may be achieved by working together.
